

Committee Updates

CDE Chair Vacancies

The CDE chair application was sent out via email in February to fill the vacant chair positions. The following positions are now filled:

- Dairy Cattle Handling CDE Darla Romberger
- Conduct of a Chapter Meeting LDE Krista Pontius

The CDE committee is currently seeking a chair for Employment Skills. The committee is asking for recommendations of great candidates or for any individuals willing to step up and fill the chair position.

Rule Changes Deadline:

The CDE committee reviewed the currently approved timeline for all rules changes. This action occurred in response to the continued concern voiced to the committee about the difficulty of pulling the changes together by the August board meeting, and allowing all teachers to weigh in with their opinion.

Two main options were discussed, which include:

- Option 1-August 1st Deadline
 - All proposed changes are due to the CDE Committee by July 15
 - Changes are shared at a PAAE Summer Conference CDE session and published on the website for review for all teachers
 - Teachers should contact chair with opinions or suggestions about the changes.
 - All changes due to the CDE Committee by August 1
 - CDE approval occurs at August board meeting
 - Final approval at December Meeting (2 votes required for policy changes)

- Option 2-December 1 Deadline
 - All proposed changes are due to CDE committee by October 1
 - Changes are shared at PAAE regional meetings and published on website for review by all teachers
 - Teachers should contact chair with opinions or suggestion about the changes.
 - All changes due to CDE committee by December 1
 - CDE approval occurs at December board meeting
 - Final approval at March meeting (unless we would revisit the board policy requiring 2 votes to pass CDE changes)

No recommendation will be provided at the March meeting. However, this item will be discussed more at the April/May CDE committee meeting and a recommendation will be provided at the May board meeting. The committee welcomes comments and suggestions from all regions and CDE chairs as a recommendation is developed.

SLLC CDE/LDE Workshop: The CDE Committee will be holding a 30 minute Q&A session at SLLC to clarify all questions and concerns with this year's changes. Time and specific room: TBD, but slated for Monday morning. Watch for an email for more details and the final announcement.

State Officer Recommendations on 2016 Delegate Issues

Recommendation 1

Committee for Creating Funds for Members to Attend Conferences and Conventions

Whereas, the committee proposes the establishing of a committee that will create half and full scholarships for students in need; locate funds for these from state FFA budgets; scholarship amounts will be left at the discretion of the committee; students will apply for a state scholarship only for state conferences and conventions; and applications must be submitted 30 days prior to an event.

Be it resolved, that we the 2016-2017 PA FFA State Officers recommend that no action be taken on this issue for the following reasons: it is a local level issue that some chapters already address; the PA FFA Foundation already raises funds to keep costs down; and there are current state programs in place that award members (ex. Jacket Campaign, WLC Scholarships, etc.).

Recommendation 2

Committee for Creating a Parliamentary Procedure Exam for Second Year Scholar Applicants

Whereas, the committee proposes a basic parliamentary procedure exam for second year scholar applicants in which an 80% or higher must be scored; the chapter advisor must sign off on it; the exam will be available upon release of the application but must be turned in one week prior to applications; applicants may only take the test once per year; and the test will consist of new material each year.

Be it resolved, that we the 2016-2017 PA FFA State Officers recommend that no action be taken on this issue for the following reasons: it is not necessary to be well rounded in parliamentary procedure to apply and serve; an exam might deter applicants; and there is no way to manage the integrity of the exam when administered at the chapter level.

Recommendation 3

Committee for Creating a Horse Showmanship CDE

Whereas, the committee proposes a Horse Showmanship CDE to include: a qualifying event at the county level in which the top 3 will advance to state competition; the same written test administered as Horse Evaluation; participants must show in both Western and English classes with a horse assigned to them being judged only on showmanship; and test scores will be combined with showmanship scores to find an overall placement.

Be it resolved, that we the 2016-2017 PA FFA State Officers recommend that no action be taken on this issue for the following reasons: the two horse related CDE's will conflict if ran simultaneously; there are safety concerns; it is a struggle to obtain horses to use; owners may not want students riding their horses; PSU horses are not trained enough for students to use; there is added liability; the length of each horse CDE would not fit in required time; each student would need to show individually, one at a time; this is adding another CDE that would stop at state level; a new chairperson would be required; funds for team/individual payouts and to obtain horses would need to be raised; and how consistent would county/regional competitions be to qualify for states.

Recommendation 4

Committee for Allowing Agriscience Fair to be Judged Virtually

Whereas, the committee proposes allowing live, virtual presentations to be conducted as a last resort, which will allow for equal opportunity for all participants.

Be it resolved that we the 2016-2017 PA FFA State Officers recommend that action be taken to pass this issue for the following reasons: this would allow all participants to interview in situations of emergency, bad weather, etc.; the same judging criteria could be used for interviews; digital copies of the lab reports, poster and lab notebook are to be submitted; and this will remain at the discretion of the chairperson. However, there are concerns to be addressed to allow this to be successfully carried out: internet availability/signal strength at the farm show; location at farm show to allow compatibility of virtual judging; and would PA FFA provide laptops/tablets in order for the judging to occur.

Recommendation 5

Committee for Allowing 9th and 10th Grade Members to Participate in FFA Knowledge CDE

Whereas, the committee proposes the FFA Knowledge CDE be open to all first and second year members and the creation of a basic first year division and an advanced second year division.

Be it resolved that we the 2016-2017 PA FFA State Officers recommend that action be taken to pass this issue for the following reasons: creating two divisions will challenge members of different age groups; the CDE would become more inclusive, allowing more members the opportunity to compete; and would increase the participation in the CDE. Due to arranging logistics of the CDE and funding for awards, we also recommend this formally be referred to the CDE Committee to be investigated and discussed further.
