Spring has sprung and FFA events in the region are completed for another school year. Public Speaking and Parliamentary Procedure CDEs were held on April 16 at Mill Creek Lutheran Church. All events were well attended but only 2 of our 4 areas were represented. For the first time in several years we had 3 Parliamentary procedure teams. I attribute this to our Teach Ag Parliamentary Procedure specialist and student teachers.

Our big spring regional CDE day was held on April 28 with approximately 550 students in attendance at the Lebanon Expo Center. Students competed in livestock judging, poultry judging, wildlife, vet science, agronomy, floriculture, small gas engines (for 1 area only), farm business management, food science and ag sales. We did not have a regional meats event this year. Approximately 50 New Jersey students plus advisors joined us to compete in poultry, agronomy and food science. Our CDEs served as qualifying events in these areas. Two New Jersey state officers and a representative from their state office also joined us. Two PA state officers assisted as well as 15 of our PSU student teachers and 2 DelVal student teachers. Since I have not heard otherwise I will say all went well. The new director of the Expo Center was impressed with our students.

Concern expressed by one advisor on needed to do 3 registrations for PSU – FFA Week because of the number of students, advisors and chaperones attending. I believe quite a few had to do 2 forms.

I attended a meeting co-chaired by Sec. Redding concerning ag careers, especially high tech ones involving GPS in equipment. Dealers are reporting a very difficult time finding qualified individuals to fill positions. Other employers reported shortages in the food processing area as well as diesel mechanics, conservation (those writing conservation plans and doing environmental permitting). Also a lack of soft skills in general coupled with leadership and communication skills. Employers were surprised that there are over 3000 agriculture students in a four county area here in the east.

Several employers talked about their inability to fill internships for high school students.

One conclusion was that there appears to be a communication breakdown between employers and our teachers. Future meetings will look at what can be done.

2015 CONSTITUTIONAL AMENDMENTS TO BE PRESENTED TO THE DELEGATES

1. Article VIII - Section (E)

"In the event of a situation that is deemed an 'emergency' by a minimum of two board members that requires the immediate attention of the board, an electronic meeting (telephone conference or online video conference) may be requested, providing that there is a minimum of a 72-hour notice prior to the meeting to the executive committee via email."

CURRENT - There is no Section (E)

2. Article X Amendments

REPLACE SECTION A:

"Amendments to the Pennsylvania FFA Constitution / Bylaws will be made by a 2/3 majority vote of the delegates present or a majority of the entire membership at the annual Pennsylvania FFA Summer State Convention. Constitutional changes must be advertised to FFA chapters via the Pennsylvania agriculture teacher's list serve maintained by the Penn State Center for Professional Personal Development at least 30 days before being considered by the assembly."

CURRENT

Section A. Amendments to this Constitution and By-laws shall be submitted in writing at the annual business meeting of the Association. Proposed amendments may be adopted or rejected by a two-thirds vote of the delegates present.

Section B. By-laws may be adopted to fit the needs of any local chapter providing they do not conflict with the Constitution of the National Organization or the State Association.

3. Article VI OFFICERS - Section A

ADD - State Officers may only serve one term.

CURRENT

Section A. The officers of the Pennsylvania Association shall consist of a President, State Vice- President, four Vice Presidents (one from each region), Secretary, Treasurer, Reporter, Sentinel, Chaplain, an Adult Treasurer, an Advisor, and Executive Manager. All officers with the exception of the State Advisor, Adult Treasurer, and Executive Secretary shall be elected annually by a majority vote of the delegates present at the annual business meeting of the Pennsylvania Association of FFA, Inc. (ENTER NEW LANGUAGE HERE) The Program Specialist of Agriculture Education shall be the State Advisor. The Board of Directors shall appoint the Adult Treasurer and Executive Manager.

4. Article VII – Section D. (NEW)

A standing CDE committee will report to the PA FFA Board of Directors at each meeting on CDE issues. Committee members will include representatives from: PSU, PDE, PAAE (CDE Liaison), Foundation and current FFA Board member.
