The meeting was called to order by President Anderson at 9am. The State officers conducted opening ceremonies followed by introductions. Herr/Harrell moved to accept the May minutes as presented. Motion passed. Anderson/Kline moved to concur. Motion passed.

Brammer reported on proposed dates of the 2021 Convention and Activities Week – June 1-3, 2021. NOT CONFIRMED YET! A newly revised budget was presented. *Bastian-Brown/Musser* moved to accept the new revised budget. Motion passed. Brown/Anderson moved to concur. Motion passed.

Herr presented the State Officer team review of activities since the new team was elected.

Anderson turned the duties of the chair over to President Miller.

STANDING COMMITTEES

CDE/LDE Committee – Barzydlo presented the following:

- That no additional selection process to determine declarations for Nationals in 2020 be developed. As there will not be CDEs or LDEs at the National Level this year, we do not feel it is a good use of time to develop a selection process to select teams or individuals to be declared just for the sake of recognition.
- 2. That the winners of events held at the 2020 PA Farm Show (Agriscience Fair and Ag Issues) be declared to Nationals for 2020 to receive recognition as they were selected using the Official Process before COVID-19 procedures needed to be put in place.
- 3. That PA adopt the same eligibility standards as National FFA will be using, allowing for eligibility based on age/grade for 2019-2020 for all events. The intent of this would also be for it to extend to all the local events, especially when qualifying rounds for State Level competition exist (Public Speaking, SGE, Safe Tractor...)

We also discussed the potential for additional cancellations of fall 2020/winter 2021 events. The Committee's plan is that we would reconvene to tackle that issue if we find ourselves in the midst of it. A possible solution would be to use the results from fall 2019 and winter 2020 to determine who should advance to States and who would be declared for Nationals. We feel it is too early to make that determination, especially as we all wait to hear from our school districts about plans for classes in the fall and travel restrictions for field trips and competitive events.

Kline/Anderson moved to accept the three bullet points. Motion passed. O'Brien/Herr moved to concur. Motion passed.

Section II: Membership

II.a. Affiliate Fee Deadline

Schools will submit the agriculture teacher(s) schedule with enrollment and counts of non-duplicated students by April 15th. If the enrollment documentation does not match the FFA Roster or has more members which include graduates, the following actions will take place:

1. Teacher will have 15 days to correct the roster upon notification of the roster discrepancy.

2. If after 15 days the FFA roster is not corrected then the chapter will be determined as not be in good standing.

3. A chapter not in good standing will not be allowed to participate in any state level activities effective immediately.

4. Once a chapter corrects the roster discrepancy, the chapter will be on good standing and allowed to participate in any state level activities.

School Districts will submit documentation and verification form with signatures of school guidance counselor and school administrator to the FFA Executive Secretary by April 15. The preferred delivery of submission is electronic.

Anderson/Kline amended by including If course enrollment documentation does not match the FFA Roster (in school and graduates) or has more students than the FFA Roster, the following actions will take place – AND striking out the language marked through above. Amendment passed. Main Motion as amended passed. Bastian-Brown/Lehman moved to concur. Motion passed.
