CDE/LDE COMMITTEE

Recommendations

Recommendation 1: Accept the proposal submitted by the Senior Prepared Public Speaking and Conservation Public Speaking LDE chairs.

Conservation and Senior Prepared Speaking Events

Board Recommendation

As per the public speaking chairs, it is our recommendation to the FFA board to combine the Conservation and Senior Prepared Speaking events. These events would align to National FFA rules by following the suggested format below:

• Qualifying competitions in both Conservation and Senior Prepared events, county through regional, would not have to change the manner in which those events are conducted.

Manuscripts:

- 1. All 24 state-level manuscripts will be judged by one qualified judge prior to activities week, and those scores will be provided to pool and finals round judges as each speaker presents their speech.
- 2. The National FFA's manuscripts rubric will be used. These are the only raw rubric scores that are made available to contestants.

Tuesday Afternoon

Conservation and Senior Prep regional place winners compete in a Preliminary Pool Round:

1. All 24 entrants would be divided into four pools, each with six competitors, as follows:

- 2. Pools would compete simultaneously.
- 3. Each pool would be evaluated by at least two judges using the National FFA scoring rubrics. Each judge's rankings would be used to place the top two competitors in each pool, leaving eight finalists to advance to the Final Round on Wednesday morning.
- 4. Each speaker would receive judge feedback forms for at the conclusion of each round.
- 5. The Preliminary Pool Round would require four rooms.
- 6. Speakers eliminated in the Preliminary Pool Round would win bronze certificates. They would not be called to the stage at the awards session.

Wednesday

Qualifiers from the Preliminary Pool Round compete in the Final Round:

- 1. The Final Round would be judged by a group of three new judges using the National FFA scoring rubrics. Each judge's final rankings would be used to place all eight competitors.
- 2. The Final Round would require one room, preferably an auditorium.
- 3. Finalists placing eighth through fourth would receive silver certificates, and they would receive their awards at the awards session.
- 4. The winner of the Final Round would compete at The National FFA Convention, and 2nd place goes to The Big E. The top three places would receive gold certificates, and they would be recognized on stage at the awards session.

Speakers that are eliminated in the Preliminary Round:

- 1. During registration all speakers must register for a day two event or will be required to attend the Prepared Public Speaking LDE to observe the top eight speakers.
- 2. The following CDE's are single day events and participants may pre-register for these events:
 - a. Wildlife
 - b. Aquatics
 - c. Land Judging
 - d. Meats Evaluation
- 3. If a speaker does not report to their second day event, they will be disqualified from the Prepared Public Speaking LDE.

Other Suggestions:

1. The committee would like to keep the current chairs and co-chairs of the Conservation and Sr. Prepared LDE.

Recommendation 2: The payouts for the combined Conservation Public Speaking and Senior Prepared Public Speaking LDEs should be consistent with all other public speaking LDEs.

Recommendation 3: Accept all CDE/LDE rules as posted on the website.

Recommendations

Changes to Proficiencies

- 1. Chapters submitting proficiency awards will be required to have a minimum of one teacher representative or proxy participate in the scoring process. A teacher representative may not be a current or future student teacher and may not represent more than one chapter.
- 2. A chapter may only submit a maximum of two proficiency applications in each proficiency category at the state level
- 3. A student may only submit a maximum of two proficiency applications per year.
- 4. Each proficiency category's applications and scoring results will be reviewed by a final review committee to ensure consistency and accuracy of applications. The four regional coordinators and the SAE specialist will serve as the final review committee.
- 5. If an application has a final average score less than 50 points, it will not be eligible for state winner or state finalist recognition.

Changes to Keystone Degree Applications

6. Applications will require all SAE plans.

Changes to Keystone Degree Applications Continued...

- 7. Applications will require a minimum of one picture of his/her project.
- 8. Keystone Degree applications will be locked to AET.
- 9. A combination of hours and money as the minimum requirement for the Keystone Degree Application will be implemented in the online application.
- 10. Other Keystone Degree application changes:
 - a. Remove "met" checkbox from the activity verification and change to a "manual check."
 - b. Add Community Service to the manual check.
 - c. Change community service "Organization" category title to "Benefitting Organization."

Other Discussion

1. The special committee recognizes and approves the use of livestock raised as a 4-H project as an appropriate SAE.
