<p>Event Type: Individual-Grades 9-12</p>	<p># of Team Members: 1</p> <p>Each region is allowed to send 3 individuals to the state event (3 per region; 12 total for the event). Each region may decide how to select their 3 participants.</p>
<p style="text-align: center;"><u>Individual Materials List</u></p> <p>Bring enough items for 15 participants</p> <ul style="list-style-type: none"> ● Laptop or iPad that can connect to PSU wifi (even if you are not using it for your lesson). ● Pencil/Pen ● Individuals are expected to provide all teaching materials required for the lesson, which could include: <ul style="list-style-type: none"> ○ Materials used in the lesson ○ Props, posters, and visual aids ○ Safety equipment for all participants, if needed (ie safety glasses, gloves, etc) ○ Copies of all handouts, papers, rubrics, etc must be provided by the members 	<p style="text-align: center;"><u>Group Materials List</u></p> <ul style="list-style-type: none"> ● All materials needed for group activities will be provided by the event chairs.

Written Exam (25 Questions)	50	<p>The written exam tests a member's content knowledge about agriculture education. Additional details include:</p> <ul style="list-style-type: none"> ● Exam will consist of 25 multiple choice questions relating to FFA, SAE, classroom instruction, differentiated instruction, careers in agriculture science, and agriculture general knowledge. ● See the resource list below for study materials. ● Time limit = 30 minutes
<p>Lesson Plan (Submitted to Chair in PDF form)</p> <p>Must use the provided template and follow the rubric</p>	200	<p>The lesson plan portion of the event evaluates a member's ability to plan curriculum. Additional details include:</p> <ul style="list-style-type: none"> ● Members must plan a lesson based on the rotating pathways for the year. These include: <ul style="list-style-type: none"> ○ 2025-Animal Systems, Power, Structural, and Technical Systems ○ 2026-Plant Systems, Environmental and Natural Resource Systems ○ 2027-Food Products and Processing Systems, Leadership Development ● Members must use the provided template when planning their lesson. ● Lesson plans and ALL supplemental materials should be submitted to the chair(s) by June 1 in PDF format.

		<ul style="list-style-type: none"> ● All supplemental slides, handouts, graphic organizers, etc must be included with the lesson plan. ● All lesson plans and materials will be shared with PA Ag Teachers for use in their classrooms at the conclusion of the event. ● Your lesson plan will be reviewed after the June 1 deadline. The event chairs will reach out if changes are needed due to safety or Penn State policy violations.
<p>Teaching Demonstration</p> <p>Rubric</p>	<p>300</p>	<p>The teaching demonstration will be a member's opportunity to teach a section of their lesson live to agricultural education students in grades 9-12. Additional details include:</p> <ul style="list-style-type: none"> ● The member can choose what section of their 45 minute lesson plan they choose to present. Only a 15 minute section of the lesson will be taught during the demonstration. Highlight on the rubric which section of the lesson will be demonstrated. ● 15 minutes of prep time is provided in another room. Then 5 minutes of set-up is allowed in the demonstration room. At the end of 5 minutes, the 15 minute demo will start. Here is a sample schedule for a competing member during the Wednesday demonstration day: <ul style="list-style-type: none"> ○ 9:00-9:15-Lesson Prep in another room ○ 9:15-9:20-Set up in Demonstration Classroom ○ 9:20-9:35-Lesson Demonstration ○ 9:35-9:40-Clean Up ○ 9:40-9:55-Reflection ○ 10 AM - 4 PM-Serve as a “student” for other contestants ● Time limit for the lesson is 15 minutes. When a member reaches the 15 minute mark, the lesson will be concluded immediately by the event official. ● Individuals are expected to bring enough copies/teaching materials/supplies for 15 participants. These items could include but are not limited to: <ul style="list-style-type: none"> ○ Materials used in the lesson ○ Props, posters, and visual aids ○ Safety equipment for all participants, if needed (ie safety glasses, gloves, etc) ○ Copies of all handouts, papers, rubrics, etc must be provided by the members ○ Additional technology needs beyond what is provided by event chairs (ie: iPads, lab sensors, etc) ● Event officials will provide a computer, projector, and whiteboard but participants can provide their own, if preferred. ● All technology and timing devices (ie cell phones,

		<p>iPads, laptops, etc) are allowed during the lesson.</p> <ul style="list-style-type: none"> ● Participants may have a copy of all prepared materials and lesson plan (paper or digital) and may use it as a reference throughout the lesson.
Lesson Reflection Activity	50	<p>Reflection is a key part of education. Members will reflect on their lesson plan and teaching demonstration. Additional details include:</p> <ul style="list-style-type: none"> ● Participants will reflect on their lesson and provide specific areas of improvement/reflections to improve the lesson in the future. ● Participants will reflect on appropriate accommodations/modifications for learning, language, and physical limitations. Responses must provide clear action that would be implemented if the lesson was taught again. ● Time limit-15 minutes
Professional Collaboration Activity	100	<p>Agricultural educators must collaborate effectively, even with team members they just met. The professional collaboration activity pairs members from <u>different chapters</u> into a group to complete an activity. Additional details include: Planning: 30 Minutes</p> <ul style="list-style-type: none"> ● Members will be randomly assigned into groups of 3-4. No members from the same chapter can be grouped together. ● Members will work together to address the practicum provided by the event chair. These practicums will rotate on an annual basis based on the 3-Circle Model. These could include the following: <ul style="list-style-type: none"> ○ 2025-FFA <ul style="list-style-type: none"> ■ Designing a new CDE/LDE ■ Preparing and plan for a chapter fundraiser ■ Develop an outline for a banquet ■ Develop a coaching plan for a CDE/LDE ■ Plan a 30 minute chapter officer leadership training ■ Recruitment for your chapter ■ Other ○ 2026-SAE <ul style="list-style-type: none"> ■ AET Records ■ SAE Plan ■ Promotion of SAE participation/SAE Spotlight ■ SAE FAQ for Parents ■ Other ○ 2027-Classroom/Laboratory <ul style="list-style-type: none"> ■ Budgeting for classroom supplies ■ Supply orders for lesson

Presentation: 5-10 Minutes

- Each team of 3-4 will have the opportunity to present their Team Collaboration Activity to a panel of judges for evaluation.
- Judges will ask questions about the content of the presentation

Causes for Disqualification:

- Use of electronic devices (phones, smart watches, headphones, etc) during exam
- Copying and/or using a pre-developed curriculum for your lesson. CASE and other curriculum resources may be used in pieces or as references but cannot be used in their entirety for the lesson plan and live lesson component.
- Disrupting, tampering, or violating the FFA Code of Conduct while participating as a “student” during another participant’s demonstration portion (Ex: talking loudly and not following directions with the intent to harm the lesson of the competing member).
