State Legislative Leadership Conference

Purpose: The State Legislative Leadership Conference (SLLC) will be held March 15-17, 2020 in Harrisburg, PA. Approximately 450 PA FFA members participate in workshops focusing on the legislative process, parliamentary procedure and state government. During workshops members are assigned to the “House” and “Senate” and debate current bills that are on the legislative floor in Harrisburg. FFA members develop career, leadership and life skills during these interactive and hands-on workshops.

On Monday afternoon, all members and advisors participate in a community service-learning project within the Harrisburg area. This project kicks off FFA community service projects across the state as FFA members return to their local communities and conduct their own service-learning projects, fulfilling their mission, “living to serve.”

This two-night, three-day conference concludes on Tuesday morning with a legislative breakfast attended by over 50 Pennsylvania Legislators. The students are seated with their Representatives and Senators to discuss the bills debated at the conference. To wrap up the event FFA members and advisors tour the state capitol and try to connect with their representatives.

The PA FFA Foundation is seeking partnerships of this conference to assist PA FFA members’ attending the conference by reducing registration costs. Partners are invited to attend any segment of this conference and may enclose a “welcome” letter in each FFA member’s conference notebook. For the legislative breakfast, major partner banners are placed throughout the dining room for additional recognition.
