### Program Overview

Agriculture is Pennsylvania's and the Nation's top industry! Both the Oley Valley School District and I understand the implications of that statistic. Without agriculture education, our country's stability, productivity, and welfare are at risk. For those reasons, and so many more, I realize how important it is to prepare my students for the future of agriculture. The agriculture education program at Oley Valley is one of several in Berks County. Berks County is a robust area thriving with agricultural. Our county ranks 2<sup>nd</sup> in the state for mushroom and alfalfa hay production, 3<sup>rd</sup> for apples, soybeans and corn grain production, and 4<sup>th</sup> for dairy and nursery/greenhouse production.

Oley Valley is an extremely rural area of Berks County with values set in traditions but goals in the 21<sup>st</sup> century when it comes to education. With advancements in agriscience, biotechnology, and progressive agriculture, students are continually intrigued by the diversity of courses offered through agriculture education. Our Agriculture Education Department at Oley Valley High School proudly includes over 100 students. Our program offers two core courses of Agricultural Environmental Science and Agricultural Biology to be taken during 9<sup>th</sup> and 10<sup>th</sup> grades, followed by several yearlong elective courses in Plant Science, Animal Science, Food Science, Advanced Environmental Science and AP Environmental Science. This year an 8<sup>th</sup> grade Exploratory Agriculture trimester course was implemented to increase agricultural literacy to all students in the district and encourage more students to pursue careers in agriculture.

### Teaching Philosophy

Agriculture is a dynamic, rapidly changing industry that has an exciting future. The "New Agriculture" consists of the intriguing new frontiers in biotechnology. These frontiers offer new opportunities for learning with exciting experiences and future careers for students enrolled in agricultural education.

As an Agricultural Educator, I believe in the complete program that follows the three-circle model of Classroom/Laboratory Instruction, Supervised Agricultural Experience (SAE), and FFA. I believe that all of these components need to be an integral, intracurricular component of the agricultural education program.

Gandhi once said, "Live as if you were to die tomorrow. Learn as if you were to live forever." This quote embodies my philosophy of agricultural education. I want my students to live as if there is no tomorrow, and take every opportunity they can. I want them to value their education so that they become hungry for more. Agriculture is such a dynamic, rapidly changing industry that there is always more to learn and more to experience, and it is my goal as an educator to provide the complete educational experience and prepare them for future careers in the "New Agriculture".

### Instruction

I use a variety of tools in my instruction to engage my students in their learning and create lasting memories. Some of these tools include: a food science lab, microscopes, dissection kits, embryology equipment, greenhouse, tissue culture facility and nearby stream. Through project based learning, students are able to utilize these various learning media to create interactive and informative presentations and projects. It is a firm belief of mine that you do not need the best or fanciest tools to provide the best education but rather the ability to take the available resources and create hands on experiential learning opportunities. I am lucky to teach in a school district that has been fortunate enough to provide its students with quality equipment and supplies. Our agricultural department even under went an extensive rennovation in 2006 to convert the traditional AG mechanics shop into an elite food science facility and laboratory to promote a more science based agriculture program.

I continually use questioning methods for students to find the answer they desire and devulge themselves in the deeper meaning behind their learning. I often find that it is easy for a student to memorize information; however, if they are given real-world expriences, which leave an imprint on

their memory, they are sure to internalize the information for an extended period of time. As an educator, I strive to provide the best learning experience possible with scientific backing to leave a lasting impact on the lives of youth.

### Experiential Learning

Through hands on, experiential learning, I am able to keep my students focused and engaged through every lesson. Many of the courses involve numerous individual and group projects as the main form of assessment. As science standards continue to be stressed across all areas of curricula, students at Oley Valley are encouraged to pursue all venues of academia. Our agricultural education courses teach students about our food, fiber, and natural resource sciences with the overall goal to develop them into young adults with an understanding of applicable sciences relevant to the progression of society. I am a firm believer in our three-circle model because it allows me to engage any student in multiple venues. I involve my students in agriscience discussions, which will lead into a research project, and then maybe into a research SAE. Our FFA chapter that consists of over 75 allows students to participate in the different CDE's which offer a hands-on, real world career perspective and I strive to incorporate the aspects of these events into my curriculum for all my students to experience.

### Student Organizations

I fully devote myself, and work diligently to incorporate interconnectivity through the model of agricultural education. Through focusing on the three components - Classroom/Laboratory Instruction, Supervised Agricultural Experience, and FFA - I find that program success ultimately leads to student success. After learning the theory components of education in classroom and laboratory settings, students are able to apply what they learned through various venues offered through FFA CDE's. In my short time at Oley Valley, I have seen the success of several of our students in these Career Development Events. This past year I helped coach a Milk and Milk Quality CDE team that went on to place first at the Eastern States Exposition and an Environmental Science and Natural Resources CDE

team that went on to place fourth at the FFA National Convention. Further extending their learning, students have the opportunity to produce SAE record books, which allow them to work on an individualized project with the guidance of my co-teacher and myself. As an added benefit, many students within the chapter and program are members of other prestigious organizations like the Envirothon team. As Envirothon advisor, I have had the opportunity to teach students about wildlife, aquatics, forestry, soils, and current issues in our environment. This past year we had the top three teams at the Berks County Envirothon contest. One of those teams had the highest scores in forestry and received a mountain ash sapling donated by DCNR as a reward. The first place team advanced on to the Pennsylvania State Envirothon contest and placed  $22^{nd}$  out of 66 teams.

### **Partnerships**

I have the pleasure of working with another Agricultural Educator to form a two-teacher agricultural department. Working with him proves to be the most rewarding connection, because we have similar values and views toward student learning. His passion for student acheivement and success is incredible. Being a seasoned teacher, his guidance and support has been priceless.

Oley Valley recognizes the symbiotic relationship between agriculture and science; and therefore has joined the two departments. It has been this way for quite some time; and we have been steadily working together to provide a complete and rigorous experience for our students.

Through our local agricultural advisory board, Oley has developed many relationships with local businesses and organizations to help better our program and community. Organizations like the PA Game Commission have been a valuable in providing resources and expertise in certain areas so we can provide the best education and prepare our students for future careers. Several Oley Valley graduates are now working for organizations like the PA Game Commission thanks to the partnerships we have formed.

Lastly, the most valuable partnership that any teacher can ever create is with the parents of our students. The cooporation and support of the parents in their student's education is like a key to a lock. It is essential to open the ultimate door to success for our students.

### **Marketing**

I am fortunate within my district to have the ability to continually market the program to teachers, administrators, and the community and have tremendous support from all of them. We host several faculty appreciation events and sponsor gifts for each faculty member during National FFA Week. Our local newspaper offers a section called *Berks Country* where they feature FFA students and success from all the programs across the county. This pubplicity has been great for our students and the program. Our annual awards banquet invites parents, members, adminstrators, community members, school board and ag advisory board members all together to showcase our achievments over each year. As the FFA advisor and teacher, I continually push my students to strive for success and promote the great opportunites offered through our agriculture education program.

### **Professional Growth**

Aside from my professional life, I enjoy working with youth outside of school in the 4-H and FFA programs. I am active with the Pennsylvania Association of Agriculture Educators (PAAE). I continually look for opportunities for professional development. For example, I am currently enrolled to attend the American Wilderness Leadership School in Jackson, WY this summer.

I am a person who truly believes that we "learn by doing." My pride, passion, and perseverance have led me to a successful life thus far. As the Agriculture Teacher's Creed states, "I am an agriculture teacher by choice, not by chance," and I whole-heartedly devote myself to my students and student learning.

This year I had the pleasure of working with a great group of girls shown below as part of our Milk Quality and Products CDE Team. They earned second place at the PA State FFA Convention, which earned them the right to compete at the Eastern State Exposition or more commonly referred to as the Big E in Springfield, MA. 




Community service is an extremely important part of our lives that as an advisor I try to instill in our students. At Oley Valley our students truly learn the value of the FFA Motto: Learning to Do, Doing to Learn, Earning to Live, and Living to Serve.

One annual community service event that the Oley Valley FFA Chapter does is Graveyard Preservation. In cooperation with the Berks County Association for Graveyard Preservation, students work to clean up our local cemeteries by weeding, trimming, washing headstones, and repairing walls. While working, students learn about our local heritage from the knowledgeable volunteers with the association.

Another community service opportunity that our members started 2 years ago during National FFA Week in February was a Kiss the Cow fundraiser to benefit the local food pantry. Each year, 6-10 high school teachers are selected as



participants and milk jars are used during lunches to collect money. Students and faculty can put money in the jar of the teacher they wish to see kiss a cow. The top three teachers with the most money at the end of National FFA Week do in fact kiss a cow in front of a crowd of students and faculty that come to watch.





Last year the Oley Valley FFA received one of the Food For All grants from the National FFA Organization. We received \$2,286 to build a raised bed garden at the school. Over the course of the past vear students and members alike planted, harvested, processes, and donated over 250lbs of fresh and frozen produce to the Oley Valley Food Pantry. The students and members put in countless hours during the school year and even more over the summer to keep it producing a bountiful yield of all kinds of vegetables from potatoes and tomatoes, to peppers, peas, and cabbage. We are gearing up for another growing season and using

the garden as a valuable teaching tool within our plant and food science classes. It even served as an SAE project for a student who used the beds as research plots to see the effects of different cover crops on soil.



This summer several of our FFA members worked extremely hard to create two educational agricultural displays for the local fairs at Kutztown, Reading, Allentown, and Oley. One display was in the horticultural category that presented information on Raised Bed Gardens using our FFA Food for All Garden as an example. It explained to the public about the benefits and methods of construction. The second was in the general agricultural education category that presented information about White Tailed Deer and the study being done by the PA Game Commission in the Southeast. It explained the purpose and goals of the study and methods of gaining the data needed to better manage the deer population in our area.

This is a picture of my 8th grade Exploratory Ag students working on a Wildlife CSI Lab called "The Case of the Car Trunk Capers" that was developed by the PA Game Commission. I work with our local office to acquire the necessary supplies to do these wildlife labs that the students really enjoy. These types of activities are an example of how I use experiential learning in the classroom/laboratory setting.
